

DECLARATION OF K [REDACTED] D [REDACTED]

I, K [REDACTED] D [REDACTED], currently of [REDACTED] do hereby declare and state:

1. I am over 18 years of age and I have personal knowledge of the facts set forth in this declaration. If I were called as a witness, I would be competent, willing and able to testify to what I state herein without reservation.

2. I am a Scientologist not a staff member of any Church of Scientology at this time. I was a Sea Organization member for about 23 years from 1983 - 2006 but am no longer a Sea Org member.

3. I have three sisters, one is Susan Ward and she lives in Los Angeles and is a staff member at the Church of Scientology Western United States and my second sister is Lucy James and she lives in Texas with her husband Haydn James who I met years ago. Lucy and Haydn are currently attacking my church which is reprehensible and a personal affront to me. I have another sister, who is not a Scientologist.

4. At some point a number of years ago, I heard from Lucy that she had been fired from her job with a dentist who was also a Scientologist. I tried to get her to communicate about it to other people who I thought could help her, but she said no and then she dropped out of communication with me and I left it at that. I later heard that she and her husband had been excommunicated from our Church, and as she had already disconnected from me I did not attempt to get back into communication with her.

5. I was told that my sister and her husband are claiming that I was forced to disconnect from them due to their actions against my Church. In actual fact, my husband Thomas and I chose not to be in touch with my sister and her husband because we don't agree with what they are doing. It is completely a matter of choice for us, not anything the Church has "forced" or asked us to do. I do not treat it lightly when anyone attacks my Church and especially my own sister who should know better and not attempt something that affects me personally, even if indirectly.

6. I was also told that Lucy claims the Church sent her out to England as a punishment when she refused to terminate her pregnancy. That is a blatant lie. In

actual fact, as there were different levels of Church staff and Lucy and Haydn had been in a middle management level, when someone became pregnant, it was broadly known policy at that time that you could have children at a lower level of Church staff, but not at a management level, so she and Haydn went to the United Kingdom to work at the Church in Birmingham, England. I remember that before they left the United States, Lucy got a book about England with pictures in it and she showed it to me. She never communicated any upset about going to England or any claim that she was being punished; to the contrary, it was very clear to me that she was interested in going to England and I thought she was excited about it.

7. Sometime after they got to England, I don't know how long after, they bought a house there and when they left England they sold it. Then when they came back to the United States, they were in the Sacramento area for about a month and they bought a car there, and at some point they went to Idaho where they bought a house.

8. I know of two different policies that the Church had had over the years when a Sea Org member became pregnant. The first was that the Sea Org couple would go to a small Church to help it expand and they would be staff members at that Church. The second policy was that the Sea Org members would route off staff entirely. I never heard anything about pressure to terminate a pregnancy.

9. I have heard that Lucy is claiming that she was prevented from leaving staff when she wanted to leave staff and I cannot speak to that as I was not present, but I do know that I did not have an experience like that. When I was going to leave staff, I was treated very well. Church staff helped my husband and me get set up where we were going to live and they checked back with us to make sure everything was okay.

10. One thing that I really want to say is that when Lucy left the Sea Org, there were several people, including me, that assisted her and gave her names of people to contact to help her and her husband get jobs and set up. I remember one time we had a meal in a restaurant together with another Scientologist who I connected Lucy to and she told him repeatedly how she wants to get more involved in church activities and wants to help the church. He is also the one that assisted first Lucy and then later Haydn to get different jobs. He first helped her get a job with a Scientologist who was a CPA in Boise, Idaho. Then this Scientologist helped Haydn get a job with a chiropractor where he would fix the chiropractor's home office in New Orleans. Then this Scientologist had the idea that Lucy and

Haydn could go work for a Scientologist dentist in Texas which is what they then went to do.

11. Neither Lucy nor Haydn would have had any of those jobs if I hadn't helped them by connecting them to this other Scientologist to get those jobs, including the dentist in Texas that she worked for and now is suing. I really resent that she would take someone that we helped her get a job with and then turn around and stab him in the back by suing him. I also resent that on one hand she would tell me that she wanted to get more involved in Church activities and help the Church and now she is attacking it.

12. I think that Lucy and Haydn must be having a hard time getting jobs, so they are doing whatever they can to make a dollar, including going on television and making all kinds of ridiculous and outrageous claims about the Church.

13. This last year in 2012, the Church of Scientology of Sacramento opened up as an Ideal Organization which has been a dream of ours for awhile. My husband and I contributed to that happening and we are very proud of it. My roots go back to the Sacramento Church so seeing it turn into an Ideal Organization made me very happy.

14. I spent years in church middle management and I am very familiar with the leadership of Mr. David Miscavige, the Chairman of the Board of Religious Technology Center. I could not even dream of what he has accomplished and he has overcome all the stops and barriers and is getting done what others said couldn't get done for the expansion of the religion. I think with all of what he has accomplished and led the Church through, his actions are phenomenal.

15. On the other hand, when people are attacking the Church it is a personal affront to me. In society there are senseless shootings, drugging of children and all kinds of criminal actions. We, as a Church are trying to change those horrible actions and reverse the downward spiral of society and better the lives of people everywhere. We work on betterment activities and I highly support the actions taken by the Church and its international membership. Anyone that attacks the Church is attacking betterment activities and all that is good and decent in the world.
