

DECLARATION OF S [REDACTED] W [REDACTED]

I, S [REDACTED] W [REDACTED], currently of [REDACTED], do hereby declare and state:

1. I am over 18 years of age and I have personal knowledge of all facts set forth in this declaration. If I were called as a witness, I would be competent, willing and able to testify to what I state herein without reservation.

2. This declaration is being executed to clarify data in regards to my relationship with my sister Lucy James, a former Scientologist and Sea Organization member.

3. Lucy and I are two of seven siblings. I am the eldest and Lucy was the 5<sup>th</sup> child to be born in our family. She is 7 years younger than I, and as we grew up I mainly babysat and took care of her due to the difference in our ages.

4. Even though we both enjoyed the same religion for a number of years and were even members of the Sea Organization, ("Sea Org") the religious order of the Scientology religion, we were never truly close.

5. In approximately 1990 Lucy was assigned as the Executive Director of a Church of Scientology in Birmingham, England. She had become pregnant and wanted to remain a member of the Sea Org. In order to do so, when a Sea Org member was expecting a child in the early 1990s, she would need to hold a position in a local church until her children grew up. That was why she went to England. During the 16 years that she resided in England we spoke very little – to my best recollection about two times total. This was by choice and as a result of the distance involved.

6. When Lucy returned to the U.S. from England, I approached her on several occasions with the intention of getting to know her better and getting close in order to restore our relationship which had grown more distant in her absence. Each time I tried to re-establish our relationship Lucy brushed me off and would not allow me to really enter into any meaningful conversation. As one example of that, when we all met at our dad's place after her return to the U.S. she brushed me off and would not really talk to me.

7. In 2008 when she was living in Texas I telephoned her and told her about a new publishing release of the basic books of Scientology. I put her on hold for a few moments and when I returned to continue our telephone conversation I found that she had hung up on me. This was in actual fact the last time that we spoke, because she would never pick up the telephone when I called back.

8. I subsequently found out from a friend while I was training at the religious training retreat in Florida that Lucy and her husband Haydn James had turned on the Church and become attackers. I was upset and angry over this as it broke my heart that they would do such a thing.

9. Since Lucy has become a self-proclaimed attacker of the Scientology religion and all the people and things that I hold dear, I made a personal decision with regard to her. I simply decided to remove her from my life. This was my decision entirely and I hold to it with integrity, as for me to remain connected to her would betray that which I love most – my friends, the rest of my family, my religion and all of Mankind – to whom I have dedicated my life.

10. I have since discovered that Lucy and her husband Haydn James are now claiming that they were “punished” by being sent to a lower echelon Church of Scientology – a “Class V Org”. This is false and the contrary is true. Before leaving to the Birmingham Church of Scientology in England, they went to see our father in Sacramento to decide whether they wanted to serve in Sacramento, as he lives there and thus they would have been close to him. However Lucy and Haydn decided that they were going to England so as to be close to Haydn’s family, who live there. They had the choice of where to go and decided on England.

11. At no time did Lucy ever claim to me that she was prevented from leaving the Church or staff in 2006 – and she had several opportunities to do so. There was never any sort of claim of that nature.

12. Lucy and Haydn have also claimed that because they were religious workers at a senior Church corporation they were unable to see their daughter Katrina, who worked at a more junior echelon. This too is factually inaccurate – for it was Lucy and Haydn who made arrangements with my sister, Kathy Dainat, that Katrina move to Sacramento and stay with her. Had Lucy and Haydn not been able to associate with Katrina they would not have been able to make these arrangements with her.

13. As a final note, I have been a member of the Sea Organization for about two decades. This is my life and I love it for it allows me to do the thing that I consider most valuable not merely for myself, but for all of Mankind – which is to help people to go free. This is my purpose and I am happiest when I am doing it – which is what I do now. It gives me personal gratification such that I could never obtain elsewhere.

I declare under penalty of perjury under the laws of the state of California, that the foregoing is true and correct.
